The fee for returned checks is \$75. WAIVE SIGNATURE on overnight entries.

# Cages / Supplies / Food

Cages are approximately 24"x24"x24". New exhibitors should bring fabric and clips for the floor, sides, and tops of cages. Litter will be provided; bring your own litter pan. People food will be available.

## **Awards**

Ribbons and rosettes will be awarded in each ring in accordance with CFA rules. Household pets will be judged in all rings. Championship, premiership, and registered kittens whose numbers appear in the catalog will be scored for national/regional awards.

## **General Information**

All entries are expected to be free of fleas, fungus, and infectious illnesses. Cats and kittens should be inoculated for feline enteritis, rhino, and calici viruses and tested negative for FeLV before entry. All claws must be clipped. Declawed cats are not eligible to compete.
