In the name of God Amen: I Thomas Hagan of Charles Co. in the province of Md. being infirm of body but of sound and perfect memory do make this my last WILL Testament as follows:

IMPRIMIS - I bequeath my Soul to God who gave it to me; my body to the Earth after my departure to be decently buried at the charge of my estate and discretion of my executrix hereafter named

ITEM - I will that my just debts and funeral charges be first paid

ITEM - I nominate Constitute and Ordain my loving wife SARAH HAGAN whole and sole Executrix of this my Last Will and Testament

ITEM - I give an bequeath unto my loving son THOMAS HAGAN a tract of land called the "Sande Leavell" containing about forty-eight acres also ten acres of land out of a tract of land called "Addition of Clair" to him and his heirs forever

ITEM - I give and bequeath unto my said son Thomas Hagan one feather bed and furniture

ITEM - I give and bequeath unto my loving son IGNATIUS HAGAN sixty Acres of Land out of a Tract of land called "Clair" beginning in the second line of the said land is a Branch and including the said Sixty Acres on the East side of the said Branch to him and his heirs forever

ITEM - I give and bequeath unto my loving daughter. REBECCA HAGAN one negro girl named Lucy also one feather bed and furniture.

ITEM - I give an bequeath unto my loving wife SARAH HAGAN all the remaining part of my personal estate

I ORDAIN that this present Will be my last Will and Testament. In witness hereof I have set my hand and fixed my seal this 22nd day of Nov. 1742

ITEM: I give my loving children hereafter named: JOSEPH HAGAN, BENJAMIN HAGAN, WILLIAM HAGAN, HENRY HAGAN all the remaining part o my personal estate to be equally divided amongst the said children

ITEM: I nominate constitute and ordain my loving son BASEL HAGAN whole and sole Executor of this my last will and testament, I ordain that this will be my last Will and Testament. In witness here of I have set my and affix my Seal this the 9th day of October 1758.

She received 340 A "The Widow's Trouble" in her father's will of 1749 which lists her as Margaret Hagan (P Geo Co. Liber 27 f. 13-15, Will of Thomas Blandford). Charles Blandford also names Margaret Hagan as sister in his will of 1782 in Chas. Co. and leaves her one-half A of "Ruden" out of son Thomas' 100A "where she now lives". Also named in the will is daughter Priscilla Hagan, presumably his daughter.

Frederick Co. Deeds, 1758, F 576, Thomas Hagan with wife Margaret buys land from Richard Beal, "Fat Oxen." In the same county and year, F 681, he with wife Margaret sells/buys? something to/from Richard Henderson.

In the PMS file, it is sometimes suggested that Margaret was the first wife of Thomas of Ignatius (ACC) who settled in Prince George Co. However, Thomas Hagan of Ignatius married Grace Gwinn, and they were married by 1768 according to a deed. Therefore Margaret could not have been his first wife because she was still alive in 1782 when she receives a half acre from her brother Charles (cf... above.)

¹⁵⁶ Thomas Blandford, II died testate in Prince Geo. Co. MD 14 Jun 1749 - 7 Aug 1749. He married m Sarah Beaven, d/o Charles Beaven and Mary Marsham. In his will, Thomas Blandford II names Charles, oldest son who receive "Ryden," "Sneaking Point" and part of "Hickory Thickett" (all of the land in Charles Co.), son John, daughters Tabitha Mitchell, Margaret Hagan, Martha Clarkson, Mary Edelen, Sarah Clarkson, and grandson Philip Edelen. Wills, Liber 27, folio 13; Newman, *Chas. Co. Gentry*, 142-143.

¹⁵⁸ In 1794, there are three men named Ignatius, on with two sons 16-21. In 1795 there are three men named Ignatius in the Nelson Co. Tax lists, all listed as the only male above 16 years of age; one is designated as the son of Joseph. The other two are Ignatius Sr. and Jr. as indicated in the lists for 1793. In 1796 there are only two men named Ignatius. I think Ignatius Sr. dies 1795-1796. As a result the marriage bonds of daughters Sarah and Catherine have the names of Hezekiah as brother, and Ann as mother on them.

¹⁵⁹ According to Martha Pikell, Ann is mentioned in the will of her father Ignatius Gardiner along with her sister Susannah wife of Basil of James Jr. Magruder's Colonial Abstracts 1772-1777, vol. I, p 59: Ignatius Gardiner leaves her one negro in 1777.

¹⁶⁰ In 1785 Ignatius Hagan sells to Bennet Hagan horses, cows, furniture; Bennett releases him from rent. Wit. by Walter Hagan. Frederick Co., MD, Deed Book 5:289.

¹⁶¹ Nelson County VA Tax Lists 1785-1791 (in Nelson Co. Library) lists Ignatius Sr with 4 taxable items together with Ignatius Jr, - 0, Hasakiah -0, and Walter - 0 for the year 1791 (p 124). Ignatius Sr. & Jr. are also listed for 1789 (as Heagan another spelling!) and 1790 (p 99). I take this as an indication that at least Hezekiah is the son of Ignatius, Sr. This would make Sarah a daughter since Hezekiah signs her marriage bond as brother, cf... below. Catherine also appears; cf... below.

In 1794, the Ignatius Hagan with 170 acres on Pottinger's Creek has two sons between 16 and 21. Hezekiah does not appear on the rolls for that year, although he does appear on the VA rolls for 1791. He reappears for the first time since 1791 in 1795. Caleb whom I believe to be the other son does not appear on the tax rolls until 1799 and in 1803 he appears with a hundred acres on Pottinger's Creek.

As for the Walter who is listed with Ignatius Sr in the 1791 Census, he appears on the tax rolls through 1820, and in 1815 is listed finally with land: 85 acres on Froman's Creek in the northern part of the county. This Walter is the son of the widow Mary Hagan, but I do not know the name of her husband. He does not marry until 1813, and theoretically he could be another Walter, but no more than one Walter appears on any of the tax records which I have collected. Perhaps he is Walter, Jr. Cf... the listing among Other Hagans.

¹⁶² I include Catherine as a daughter of Ignatius Sr because he dies about 1795 (the last year in which the tax lists give three Ignatius Hagans), and therefore, Ann, his wife, would be listed on the bond; also John B. ¹⁶⁹ The information for the family of Nancy Hagan and William Smith Jarboe is taken mainly from *The Jarboe Family*, vol. 2 JT-6. Maguire says that she was the daughter of Ignatius and Anastasia (Hamilton) Hagan, he being the son of Ignatius who joined the Maryland Colonization League and that they lived on the 170 A tract belonging to Nancy's father, Ignatius located on the middle fork of the Pottinger's Creek in both Washington and Nelson Counties.

The Marriage bond of also names Ignatius as father of Ann (Nancy).

Also from the genealogy of the *Thomas Hill Family*, p 8: Wm Smith Jarboe, 12 Jan 1793 - 15 July 1868, was the son of John Thomas Jarboe and Dorothy Hill. "Dolly" was the daughter of Thomas Hill and Rebecca Miles (m 13 Nov 1753). Rebecca had a brother named Philip who accompanied Thomas Hill to KY, but the Miles father is not known although they seem kin to Nicholas father of Milly Miles. Cf. information on the Miles family. A history of the early Jarboes can be found in *History of Carrollton Manor, Frederick Co. MD*, by William Jarboe Grove, 1922 as well as in the three volumes on the Jarboes by Mary Jo Maguire.

¹⁷⁰ Hezekiah appears in the 1810 US Census as a single man without wife or family. Seemingly, therefore, his first wife Nancy Clark died early on. On 17 Apr 1815, Fr. ST Badin blessed Hezekiah's second marriage to Eleanor Bryan. In the 1830 US Census of Nelson County, "Hez" is listed between 50-60 years old with presumably his wife 40-50 yrs. old, and four children: two boys between 10-15 yrs old and two girls, one under five and one 5-10 yrs old. Horace would have been about 13 years old in 1830. Hezekiah does not appear in 1840 census of Nelson County; did he move to Marion County during that time?

From Hamilton's genealogy of Thomas Clarke Hagan; no date is given.

Tax Lists of Nelson Co. 1793: Walter Hagan is listed between Edward and Ignatius Hagan. He is credited only with one white male over 21 and nothing else. In the 1795 and 1796 lists, he also has one horse.

Beginning with the 1800 tax rolls, Benjamin Hagan's property is listed as levy free without a male over 21 years of age up through at least 1805. The size of the property drops from 300A on Pottinger in 1795 to 250 in 1800, to 225 in 1801, to 200 in 1802-1805.

A Benjamin Hagan is listed in the revolutionary militia of Charles Co; cf.. revolutionary records.

According to A. Hamilton, this Cpl. James is the son of James Sr., and she in *Genealogy of Thomas Clark Hagan*, p 7. She provides a photocopy of pension application and says: "James Hagan appeared before Nelson Co Court and gave his age as 66 years. He states he enlisted in Maryland in 1776 in Captain John Smith's Company (The 4th Regiment). His wife, aged 56 and 2 daughters, are living with him. He served in the 4th Regiment and later transferred to the Second Maryland Regiment under the command of Col Ford. He served from 1776 to August 1783 when he was discharged by Col. Brumby. He fought in the battle of Brandywine, Germantown, Camden, Guilford Courthouse and Eutaw Springs. He was shot in the hip during the last battle. Walter Hagan [also a soldier in the Revolution, cf.. Other Hagans] made oath that James Hagan was in the war for six or seven years, and he was in service as late as 1781; warrant s-36003.

Anna Hamilton, *Thomas Clarke Hagan*, p. 8. James is shown on the 1802 tax list with 100 A on Pottinger's Creek, and in 1805 he has 231 acres through 1820 when my records ends.

According to my calculations, this James would not have married Sarah Hagan, d/o Ignatius Sr. because she would have been his first cousin; she instead married James s/o Bennet. There is a proliferation of James Hagans, but in the tax rolls of 1796, 1799, 1800, 1801, there are only three, and they would be James, Jr. s/o James and Monica, James s/o Bennet, and James, s/o Ignatius AC and husband of Mary. I do not know how I came by the name of his wife as Sarah McAdams. I have no marriage records for them; possible they were married in Maryland. However, he would have known the family since his sister Sarah married Samuel McAdams.

According to Anna Hamilton, *Thomas Clarke Hagan*, James Hagan, the father of Thomas Clark, married Monica Fenwick. However, the bond which she reproduces seems to read "James Hager" as does the transcript of the Nelson County Bonds, 1785-1832. Webb in *Catholicity in Kentucky*, 110 lists a James Hager as living in the Rolling Fork community in 1800. Also Thompson in *Ky Catholic Pioneers*, lists James and Monica (Fenwick) Hager as the parents of Henry c 1807 and John c 1810.

Hamilton also lists him as the son of James and Monica Hagan. However, the children of this James are not the same as those given as the brothers and sisters of Thomas Clarke Hagan. Mr. James W. Hagan, Rt. 2, Box 344, Whitesville, Ky 42378, calls this James "James II" and does not list his wife.

E C. Hagan was born January 8, 1834 and is a son of Sidney and Nancy (Cecil) Hagan. Sidney was born in 1800, one mile east of new Hope, was reared a farmer and had 700 acres of land; he was also a large holder of slaves property; was a clerk in his young days, also carried on distilling for forty years. He was live in Marion county since 1823, and served several times as magistrate. He was son of Clem Hagan and Millie (Miles) Hagan, who were natives of Maryland and Virginia respectively, and were among the first settlers on Pottinger's Creek. Clem Hagan was a farmer an distiller, and when but a small boy he lost his parents, who were of Irish descent. Mrs Nancy Hagan was a daughter of James and Susan Hamett, who were natives of Cecil County Md. and raised a family of eight children. Ed C. Hagan was born in the west part of Marion County, was raised on a farm and received a fair English education; he spent one year in St. Mary's College, taught in the common schools a few terms, and commenced the battle of life for himself at the age of eighteen years. September 2, 1861, he enlisted in Company B, Ninth Kentucky Confederate Infantry, participated in the battles of Shiloh and Stone River, and in fact was in all engagements in which the regiment took part except Baton Rouge. At the battle of Jonesboro, Ga., he lost his right arm, was captured and sent to the hospital where he remained for eight months; he was at Camp Chase for four months when he was released at the close of the war in June 1865. He then turned to his home and engaged in stock trading two years, then engaged in general farming for seven years. In 1876 he commenced selling goods, which he continued four years, after which he returned to farming. In November 1884, he returned to the dry goods business at New Hope where he is now engaged; he was also engaged for four years in distilling. October 7 1879, he married Anna Parolee Barry, daughter of Dr. J.J. Barry and Frances Felicia Barry of New Haven, Ky. Dr. Barry was born in County Cork, Ireland, came to Kentucky at the age of sixteen, graduated in medicine in Louisville, was the author of several religious and scientific works; understood seven different languages, lived and died a member of the Roman Catholic Church. Mrs. Barry was the daughter of the Rev. Samuel Jesse of Shelby County, and is a convert to the Catholic Church; her parents were born in Virginia. To Mr. Hagan's marriage four children were born: Joseph S. (deceased), Frank Miles, Augustine Bradford (deceased), and John Sidney. Mr. and Mrs. Hagan are members of the Roman Catholic Church. Mr. Hagan cast his first presidential vote for James Buchanan.

Beginning with the 1800 tax rolls, the property Benjamin Hagan's property is listed as levy free without a male over 21 years of age up through at least 1805. The size of the property drops from 300A on Pottinger in 1795 to 250 in 1800, to 225 in 1801, to 200 in 1802-1805.

A Benjamin Hagan is listed in the revolutionary militia of Charles Co; cf.. revolutionary records at the end of this manuscript.
